KEYNOTE SPEAKERS



Mary Jane Oatman

Mary Jane Oatman is a member of the Nez Perce Tribe of Idaho. She was born and raised on the reservation to a large family that has embarked on the education journey together. She was honored to be a part of three generations graduating together, a contagion that has spread as other family members have since returned to school to continue their education journey. Ms. Oatman has been accepted into a doctoral program in the College of Education at the University of Idaho, where her studies will focus on gender in history with the project titled: "Nimiipuu women's role(s) during the Nez Perce War of 1877-Resistance & Resilience Untold." She is a graduate of Lewis-Clark State College (LCSC) with a bachelor's degree in justice studies and a minor in Nez Perce language. In 2009 she received LCSC's Alumni of the Year award and established the first-ever chapter of the Native American Alumni Association. She received a national award in 2008 from the **University Continuing Education** Association as the Outstanding Nontraditional Student.

Ms. Oatman is the President of the National Indian Education Association (NIEA) and was appointed by President Obama to serve on the National Advisory Council on Indian Education (NACIE) as a liaison to Secretary Arne Duncan in the United States Department of Education. Ms. Oatman currently serves as the Senior Liaison to the American Indian/Alaska Native (AI/ AN) communities for the Office of Minority Community Outreach at the National Education Association (NEA). She is in charge of connecting the AI/AN community to NEA's 3.2 million members and ensuring that NEA's policies and programs are relevant to America's indigenous communities. Prior to joining NEA, she served as the first appointee as the Director of the Office of Indian Education at the Idaho State Department of Education.

Ms. Oatman has two children-Jackson (9) and Wayne (3) and loves to spend time fishing for salmon, huckleberry picking, and volunteering in youth development initiatives. She says, "My greatest accomplishments and blessings from the Creator have been the gift of motherhood. My little guys are what keep me motivated and inspired to represent Indian country. Though my career has taken me far from the reservation, I will always remain tied to my roots."



James C. Ramos, MBA

James Ramos was first elected to the office of chairman for the San Manuel Band of Serrano Mission Indians on March 1, 2008. In 2011, Governor Jerry Brown appointed Ramos to the California State Board of Education making James the first California Native American to be appointed to the Board. The Board is the governing and policy-making body of the state Department of Education, and sets state-wide, K-12 education policy in the areas of standards, instructional materials, assessment, and accountability. Ramos believes that education is the key for the United States to maintain a leadership position in global affairs.

Ramos has a deep commitment to the preservation of California Indian Culture. Ramos is co-founder of the cultural awareness program at San Manuel and serves as director of the California Indian Cultural Awareness Conference held annually at Cal State San Bernardino. Recognizing this commitment, Governor Arnold Schwarzenegger appointed him to the California State Native American Heritage Commission in January 2008. He currently holds the position of Chairman.

Ramos is a proven civic leader in the Inland Empire region and has served on the boards of a number of groups and organizations promoting business, economic and social opportunities, including the San Bernardino County Museum Association, Loma Linda University Children's Hospital Foundation, Foundation Board of Governors, California State University San Bernardino, Dorothy Ramon Learning Center, St. Bernardine Medical Center Foundation, San Bernardino Valley **College Foundation**, Arrowhead United Way, and the KVCR (Public Television) Foundation for Education and Operating Board Member of FNX - First Nations Experience, the nation's first television channel rooted in the Native American experience and broadcast by KVCR.

In 2010, Ramos was re-elected to the San Bernardino Community College Board of Trustees for a second term. He served as president of the board for two terms. He is the first Native American to be elected to the board and received strong bi-partisan support from federal, state, and local elected officials and community leaders.

In addition to tribal government issues, Ramos continues to work with the tribe's agenda of community involvement by reaching out to the surrounding communities and local governments to work collaboratively on issues that improve the quality of life for all citizens.

Ramos is a successful entrepreneur, operating restaurants in the San Bernardino region. He was born and raised on the San Manuel Indian Reservation. Ramos and his wife Terri are proud parents of four children. Ramos earned an Associate of Science Degree from San Bernardino Valley College, Bachelor of Science **Degree in Business Administration** from California State University -San Bernardino, and a Masters in **Business Administration Degree** from the University of Redlands. In December 2009, he received an honorary doctorate degree in humane letters from Northern Arizona University, for his leadership and contributions to education.

INVITED SPEAKER



Tom Torlakson, State Superintendent of Public Instruction

Tom Torlakson was elected to a fouryear term as California's 27th State Superintendent of Public Instruction on November 2, 2010. As chief of California's public school system and leader of the California Department of Education, Superintendent Torlakson applies his experience as a science teacher, high school coach, and state policy maker to fight for our students and improve our state's public education system.

Torlakson's journey has led him from the classrooms of Contra Costa County's Mount Diablo Unified School District (where he remains a teacheron-leave), to the Antioch City Council, Contra Costa County Board of Supervisors, and the California State Senate and State Assembly.

During his tenure in the California State Legislature, Torlakson acted to protect education funding, improve student nutrition and physical education, and ensure school safety. He also championed legislation to increase funding for textbooks, computers, and other instructional materials and efforts to close the digital divide, eliminate the achievement gap, and reduce the dropout rate.

In 1998 Torlakson authored legislation leading to the development of the largest system of after school programs in the nation. In 2006, he authored the bill that led to a 300 percent expansion in these programs—so they now reach 4,000 schools around the state. Torlakson authored the Quality Education Improvement Act (SB 1133) in 2006, which dedicates nearly \$3 billion to our lowest performing schools. He also played a key role negotiating and authoring the \$9 billion Proposition 1A bond measure in 1998—which has led to public votes supporting over \$36 billion to build new schools and improve existing school buildings.

As the chair and founder of the California Task Force on Youth and Workplace Wellness, Torlakson has been a leader on banning junk food from our schools, providing healthier school meals, promoting student health and fitness, and combating diabetes and obesity among our children.

Born in San Francisco, Tom served as a fireman in the United States Merchant Marine, earning the Vietnam Service Medal. He earned a B.A. in History, a Life Secondary Teaching Credential, and an M.A. in Education from the University of California, Berkeley.

HONORED AMERICAN INDIAN ELDER

Given to Elders 60 years or older who have made outstanding contributions to American Indian education in the following areas:

- Promoted an understanding and appreciation of American Indian cultures in an educational or community setting;
- 2) Given lifelong service to promoting quality education through active community service; or
- 3) Served as a role model or mentor for American Indian children, youth, or adults

DISTINGUISHED AMERICAN INDIAN EDUCATOR OF THE YEAR

Given to an American Indian teacher, educator, counselor, or administrator with significant work in any of the following areas:

- Developed and established innovative education program(s);
- Improved education or cultural quality in nominee's community;
- 3) Significantly impacted a school or local community;
- Worked for passage of legislation designed to improve student service delivery;
- 5) Promoted educational quality for students;
- 6) Promoted training for teachers and counselors of American Indian students; or
- 7) Developed programs to improve the education of American Indian people

PARENT OF THE YEAR

Given to an American Indian parent for outstanding leadership, commitment, concern, and voluntary efforts in the following areas:

- Served on local, regional, statewide committees, or boards working to improve the educational quality of American Indian students;
- Demonstrated strong commitment through volunteer work to improve educational opportunities for American Indian youth; or
- 3) Worked to strengthen American Indian youth programs at the community or tribal level

STUDENT OF THE YEAR

Given to an American Indian student in the 12th Grade, enrolled full-time in a public or private accredited school with a GPA of 3.5 or higher. Nominees must demonstrate leadership qualities, maintain high academic achievement, serve as a role model for other students.

The student of the year will receive a scholarship from the Conference Committee, once proof of enrollment (minimum of ½ time) at a higher education or vocational institute is provided.

PLEASE NOTE

Awardees will receive a meal at the conference. Expenses such as conference registration, lodging and transportation are the responsibility of the nominating individual or organization. (Additional meal tickets for family members and/or friends, must be purchased separately, and may not be available unless purchased in advance of the event.) All nominees must be residents of California.

*The Indian Arts and Craft Act of 1990 shall apply to all arts and crafts vendors.

The Indian Arts and Crafts Act of 1990 (P.L. 101-644) is a truth-in-advertising law that prohibits misrepresentation in marketing of Indian arts and crafts products within the United States. It is illegal to offer or display for sale, or sell any art or craft product in a manner that falsely suggests it is Indian produced, an Indian product, or the product of a particular Indian or Indian Tribe or Indian arts and crafts organization, resident within the United States. Under the Act, an Indian is defined as a member of any federally or State recognized Indian Tribe, or an individual certified as an Indian artisan by an Indian Tribe.
